# **Reclamation Drive (TARP)**

In an attempt to give suspended Brothers an • opportunity to become active again during these tough economic times, our Most Worshipful Grand Master has devised a plan named TARP- Traveling Again Reclamation Program. • This program is designed to allow suspended members to reinstate for a more affordable fee.

Members suspended before June, 2002, can reinstate by paying the following:

- \$20.00 reinstatement fee
- \$25.00 taxes
- \$25.00 registration
- \$50.00 assessment (Have two years to pay the remaining \$150.00)
- \$120.00 Total

Members suspended after June, 2002, can reinstate by paying the following:

- \$20.00 reinstatement fee
- \$25.00 taxes
- \$25.00 registration
- \$50.00 assessment (Have two years to pay the remaining \$200.00)
- \$120.00 Total

**TARP** serves a two-fold purpose: (1.) It gives suspended Brothers a more affordable means of reinstating and (2.) It gives dying lodges a final opportunity to salvage their existence by increasing their numbers before being forced to close or merge. Our Grand Master has extended a challenge for the members of this jurisdiction to go out and reclaim our lost Brothers. TARP will be in effect through July 31, 2021.



# **1901 Proceedings**

# From Whence We've Come...

This installment is a continuation of the In Their Own Words series. We will take a look at a snapshot of the Grand Master's Address of MWPGM Chas. V. Hendley, Esq.

cetings:

Time marches on! Like a watch in the night, or a tale that is cold, 22 years and seven months have passed since that cold, dreary night of November, 1936, went in historic Tullibody Auditorium at the State Teachers College, Montgomery, Alabama, you saw fit to elect me as your sixth Grand Master. Now, 22 years and seven months afterwards, we who have been spared through the mercies of a Divine Providence, find ourselves once more gathered together in the city of Dothan, Alabama, in the First Baptist Church, for the purpose of holding our 89th annual communication (81st since consolidation). From our many homes and our various occupations and businesses, and from all sections of this great state of ours we have gathered once again to experience and enjoy the reality and truth of that scriptural statement upon which our first degree is founded.

For 89 years the Colored Masons of Alabama have rarely missed holding their Grand Lodge Session, and when in our mind's eye we look back through the years and compare the conditions and circumstances under which our forefathers gave birth to Colored Masonry in this state, with the conditions and circumstances under which we meet here today in the First Baptist Church; we cannot be unmindful of the fact that God, Himself, has watched over us and helped us in our growth and prosperity; that He has thrown around us His arms of protection, and that in His sight we have been accounted not altogether unworthy of His divine grace and protection. Therefore, in obedience to the first great teachings of our order. "That no man should ever enter upon any great and important undertaking without first invoking the aid of Deity", Let us stop here and ask the Right Worshipful Grand Chaplain to approach our sacred altar and lead us in song and prayer.

In accordance with the provisions of our Constitution and Bylaws, it once more becomes my duty, as well as my pleasure, to present to you for your information, consideration and action, a short review and report of my stewardship as your Grand Master. Also, to touch upon such matters as I think helpful to the Craft. We have been able to accomplish what we have only because of your fine cooperation and help, and I want here to again publicly express to you, and through you, to the entire Craft of this Jurisdiction, my sincere thanks and appreciation. I want you to know that your faith and confidence has been my inspiration; your support and help has been my strength; and your approbation and approval of what I have done has been one of the greatest earthly satisfactions, I appreciate highly the very great honor you have seen fit to bestow upon me during the past 22 years and seven months, and I am especially mindful of the fact that I am the first Grand Master to be elected more than 21 times without opposition. With all honor and privileges comes responsibility and obligation, and I assure you that as long as I am your Grand Master I shall continue to look after your affairs as I would look after my own, and that nothing shall cause me to swerve from the path of Masonic duty, and to perform any act not having as its motive and purpose the best interest of the Order and the Craft as a whole. Therefore, when in the administration of your affairs, I have to now and then say "No" to some of your individual requests, it is not that I think less of you, but rather that I think more of the Order and the Craft as a whole.

### Operation of lodges

I want to call to your attention to the fact that in my estimation, our local lodges are not doing nearly as much as they could to make their meetings interesting and worthwhile. I have heard so many brothers make the statement that the reason they did not attend their lodges were that nothing was done in them but collect dues and close the lodge, and that they could just as well pay their dues to the Secretary. They express the opinion that they would like to attend their lodge meetings if they were more interesting. I am therefore, asking all of the Worshipful Masters to give thought to making their lodge meetings more interesting and to remember that there are many things that could be done to make a lodge meeting more interesting and to furnish a wholesome recreation to the younger members of the lodge which would be in no case a violation of the landmarks of Masonry . Also, in this connection, I would suggest that we intelligently, thoughtfully and legally exemplify the beautiful ritualistic symbolism of our Order.

### Our dwindling membership

We continue to have a small net decrease in membership, and I am afraid that for the next two or three years it will be difficult to stop this small decrease in membership due to the detrimental effect on the well-being of our group because of the activity of the White Citizens Council and the Ku Klux Klan, both of which organizations are taking advantage of our weaknesses by using pressure, economically and otherwise when the least thing happens that they do not agree with. However, in spite of this, we can begin to increase our membership, and for the first time in ten years, I'm appealing to every lodge and all of the officers and members of every lodge, to use every effort not only to keep the membership you have intact, but to add new members an young men, some of whom are yet to be found in every community. In this connection, I also wish to recommend that every lodge create a delinquency committee, and that this connection, I also wish to recommend that every brother who is in arrears in the payment of his dues before such brother is formally suspended for nonpayment of dues. It would be helpful in this connection not only to contact the brother, but to contact his wife and others who might be dependent up on him."

We recognize that the events of 1959 are not so far away from the issues impacting our current Grand Lodge. Equally, we recognize that the leadership the Craft elected to the helm then was stellar, just as it remains to be stellar today.

We hope that you have enjoyed taking a glimpse into what our Brothers were doing in 1959, in Dothan, Alabama.

### "Touching the Past"

### **Ligon Ambrose Wilson**


Commitment, Dedication and Sacrifice, These are the words that come to mind when you consider Past Deputy Grand Master Ligon A. Wilson. So without further ado, let me introduce to some and present to others Past Deputy Grand Master Ligon A. Wilson.



Brother Wilson was born and grew up in Tuskegee, AL. He graduated from Tuskegee and Hampton Institutes and the University of Michigan. When Tuskegee Institute was looking for a President to succeed Dr. R. R. Moton, Ligon was popularly mentioned for the position. During the New Deal he headed the New York Association activities in the state among Negros. He was also the chairman of the Red Cross campaign in Wilcox County and on the board of the War Bond drive. However, he is mostly noted for being the President of Snow Hill Institute for nineteen years, until his death in 1948.

To put this historical page of history into perspective, we must tell the whole story of the other lives that he has touched and transformed, namely the black community in a little town in lower Alabama by the name of Daphne. He was the Principal of the all black Baldwin County Training School there and the first Worshipful Master of Pine Grove Lodge No. 639, which was established in 1920 during the tenure of Grand Master W. T. Woods.

As a member of Pine Grove Lodge, I was always curious of Wilson's identity, so I began my search. After searching through record after record, he was located in Pineapple, Alabama as the President of Snow Hill Institute. I then set out to find his burial spot, which led me to Ashdale Cemetery in Tuskegee. When I found him it was a surreal emotion that overcame me. At that moment I felt that I had connected with the past and my heart was full and I was satisfied with the work that had been done by so many brothers to bring all our hopes and dreams to reality. I prayed and dropped a silent tear for the journey that this Brother set me upon. Thank you, Brother Ligon A. Wilson, for doing all you could while you could, to advance the plight of our people in a different world than we live in today. Making good men better men will always be our battle cry as we celebrate the spirit of masonry that was left by you in that hollowed lodge.

# **COVID-19 Vaccinations**

Walmart and Sam's Club Pharmacies Administer COVID-19 Vaccines Through Federal Retail Pharmacy Program

Walmart and Sam's Club pharmacies will begin administering COVID-19 vaccines through the U.S. Federal Retail Pharmacy Program on Feb. 12, 2021. More than 1,000 Walmart and Sam's Club pharmacies in 22 states are receiving federal vaccine allocations this week, with an emphasis on locations that reach customers in underserved communities with limited access to health care. In addition to the 22 states, Walmart and Sam's Club is also currently administering vaccinations under the state allocation in 11 states, the District of Columbia and Puerto Rico. While initial vaccine supply is limited, Walmart and Sam's Club pharmacists and technicians stand ready to help expand vaccine access across the country.

With 150 million customers and members passing through our doors each week, Walmart and Sam's Club pharmacists can safely and easily reach customers where they're already shopping for household and health care essentials. The company worked with the Centers for Disease Control and Prevention (CDC) and states taking into account the population density, customer demographics, infection rates and availability of local health care resources among other factors to identify many of the participating locations.

The company also looked at pharmacies located in Medically Underserved Areas, as designated by the Health Resources and Services Administration. For example, the Walmart store in Brewton, Alabama, was chosen because it is in a designated medically underserved area and is the only location to administer the vaccine for 102 miles.\*

"Ninety percent of the country lives within 10 miles of a Walmart. We're at the heart of many rural and underserved communities, and we are committed to providing access to vaccines as groups become eligible," Dr. Cheryl Pegus, Executive Vice President, Health & Wellness, said. "Vaccinations to achieve widespread immunity are important for re-opening across the country. We're proud to work together with the federal government, states, communities, customers and associates to reach that goal."

Vaccine supply and eligibility will vary based on allocation as well as state and local guidelines. The number of vaccinations will be limited and is planned to continue to increase each week. Eligible customers can schedule a vaccine appointment directly via the Walmart and Sam's Club websites once appointments are available, making it convenient to get vaccinated while allocation lasts. A membership is not required to get a vaccination at Sam's Club. In addition to appointments, the scheduler will provide a digital reminder when it is time to return for the second vaccine, which is why customers are asked to create a profile, helping to ensure customers receive the second dose of the vaccine.

Walmart recognizes there are people who may have difficulty accessing in-store clinics, so it will be partnering with other providers and organizations to expand access to offsite vaccination clinics. The company will share details of these new vaccine options as they become available.

Walmart and Sam's Club pharmacies will continue to support states and the federal government to help increase the accessibility and availability of COVID-19 vaccines. To stay up to date on how Walmart and Sam's Club are supporting the vaccine rollout.

# 10 Tips for Saving for Retirement

# Abraham Lodge No. 267 Provides Thanksgiving Meals to It's Community






# Brothers Called Home by the Grand Architect
