

## Reclamation Drive (TARP)

In an attempt to give suspended Brothers an opportunity to become active again during these tough economic times, our Most Worshipful Grand Master has devised a plan named TARP- Traveling Again Reclamation Program. This program is designed to allow suspended members to reinstate for a more affordable fee.

Members suspended before June, 2002, can reinstate by paying the following:

- \$25.00 reinstatement fee
- \$25.00 taxes
- \$25.00 registration
- \$50.00 assessment (Have two years to pay the remaining \$150.00)
- \$125.00 Total

Members suspended after June, 2002, can reinstate by paying the following:

- \$25.00 reinstatement fee
- \$25.00 taxes
- \$25.00 registration
- \$50.00 assessment (Have two years to pay the remaining \$200.00)
- \$125.00 Total

**TARP** serves a two-fold purpose: (1.) It gives suspended Brothers a more affordable means of reinstating and (2.) It gives dying lodges a final opportunity to salvage their existence by increasing their numbers before being forced to close or merge. Our Grand Master has extended a challenge for the members of this jurisdiction to go out and reclaim our lost Brothers. TARP will be in effect until further notice.

This is an opportune time to stand in solidarity in support of the Voting Rights Act of 1965, which is currently under attack nationwide, in a state where a federal court recently struck down the newly drawn congressional map (gerrymandering). Consider this March as a time to remember for the seasoned brother and a history lesson for the younger brother. I am counting on you to help make this another great success.

## Obituary

Charles Vergne Hendley, born in Huntsville, Alabama, on January 31, 1892, was the son of Charles and Elizabeth Bentley Hendley. He died at the Huntsville Hospital on Saturday, May 6, 1967.

After receiving his grammar school education in the public schools of Huntsville, he entered the academy at Howard University in Washington, D. C., and remained there until he completed both his college and law school training. He was admitted to the Alabama bar upon his return to this state in 1919.

In his community, he was an activist whose humanitarian concerns resulted in the improvement of every aspect of the community that came within his influence. He began his career here in Huntsville as an educator, serving from 1918 to 1922 as principal of the public high school from which Councill High School evolved. His concern for the economic and civic development of his people was demonstrated through his association with the Longview Gin Company for which he served as auditor, secretary, and attorney. In addition, he was organizer and a guiding influence in the North Alabama Colored Fair which served as a vehicle for the development of many community interests and talents. He was a member also of the Lakeside Methodist Church of Huntsville.

His membership in fraternal organizations provided the means through which his most significant contributions were made. He was grand attorney of the Alabama Grand Lodge of Knights of Pythias, member, treasurer and former Worshipful Master of Evening Star Lodge Number 6 and Grand Master for 32 years of Prince Hall F. & A. M. Masons of Alabama, receiving the highest rank of 33rd degree mason. As a result of his expert guidance and shrewd wisdom, the state organization grew in every dimension. According to the most current records, the membership of 6,000 when he became grand master 32 years ago, increased, under his leadership, to more than 27,000 brothers, and assets grew from one-half million to more than five million dollars. During his term of office, the operational budget of the temple in Birmingham grew from a deficit of \$54,000 to a surplus of \$150,000. From the confusion and lack of confidence 32 years ago, there developed an atmosphere of stability, and a feeling of trust, goodwill and confidence. And what is even more important than these numerical statistics was his recognized ability to inspire the men of his order, by his own example, to stand tall in their communities, speak forthrightly, live nobly and achieve substantially.

Those of us who live after him and were privileged to know him can carry on his work, being guided by our memory of him as a man of strict principles, and firm and honest judgment who always sought the truth and expressed it courageously without fear or favor.

His survivors include his wife, Mrs. Ann K. Hendley, Huntsville, one sister, Mrs. Faye H. Davis; a niece, Mrs. Faye D. Boulware, and a grand nephew, William H. Boulware, New York City.

## .Dealing with Novel Coronavirus

Novel Coronavirus, or COVID-19, is an infectious disease caused by the SARS-CoV-2 virus.

Most people infected with the virus will experience mild to moderate respiratory illness and recover without requiring special treatment. However, some will become seriously ill and require medical attention. Older people and those with underlying medical conditions like cardiovascular disease, diabetes, chronic respiratory disease, or cancer are more likely to develop serious illness. Anyone can get sick with COVID-19 and become seriously ill or die at any age.

The best way to prevent and slow down transmission is to be well informed about the disease and how the virus spreads. Protect yourself and others from infection by staying at least 1 meter apart from others, wearing a properly fitted mask, and washing your hands or using an alcohol-based rub frequently. Get vaccinated when it's your turn and follow local guidance.

The virus can spread from an infected person's mouth or nose in small liquid particles when they cough, sneeze, speak, sing, or breathe. These particles range from larger respiratory droplets to smaller aerosols. It is important to practice respiratory etiquette, for example by coughing into a flexed elbow, and to stay home and self-isolate until you recover if you feel unwell.

## 4 Steps to Attainable Financial Goals

Setting **financial goals** is essential to creating a financial plan—learn how to create goals and **measure your progress** toward them.

Imagine you're planning a family vacation, and your spouse wants to drive, while you want to book a flight. If you're planning a trip to the campground near your house, it would be ridiculous to fly; if you're planning a trip to Europe, driving is out of the question. Your destination largely influences how you will get there, and it's the same with financial planning. Before you think of choosing investments or forming an estate plan, you first have to establish your financial goals. After all, until you choose your goals, you have no way of making progress toward them.

### Step 1 Establishing goals

To determine your financial goals, start by identifying

things that will make you feel happy, fulfilled and financially secure. Overall, your goals should be a balance between these things if your goals will make you financially secure but miserable, or happy but financially insecure, you need to reconsider. It's likely, based on these requirements, you'll define a combination of short-term, intermediate and long-term goals. Short-term goals can be accomplished within the next year, such as saving for an annual vacation. Intermediate goals will generally be accomplished within the next two to five

than five years away, such as saving for retirement or your children's college education. Although goals may have different time frames, they should still be planned in coordination with each other, as achieving your short-term goals may affect your long-term goals. For example, a short-term goal may be to meet all of your mortgage payments for the next year, while a long-term goal is to own your own home. If you can't meet the short-term goal in this case, you're much less likely to achieve your long-term goal.

### Step 2 Specifying goals

Some common financial goals include buying a house, getting out of debt or saving

for retirement. If everyone could simply list these as goals on a financial plan, this step would be a lot easier. However, goals

mean different things to different people. For one person, buying a home may mean paying \$100,000 while to another it may be \$2 million. In addition to being specific, goals should have a time frame, be measurable, be realistic and indicate a course of action. For example, instead of “buying a home,” your goal could be: “I want to put 3 percent of my paycheck into a savings account each month so I can buy a home within the next five years, with a mortgage payment below \$3,000 per month.” By setting specific, realistic goals, it’s easier to measure your progress toward them, and your likelihood of achieving them will increase.

### Step 3 Prioritizing goals

If you have a list of financial goals, boost your chance of attaining them by prioritizing them as primary goals and secondary goals. You can rank goals in terms of both urgency and importance. For instance, contributing to your retirement fund is important, but it may have to come second to paying off credit card debt, which is more urgent. If you have conflicting goals, such as saving for retirement

and your child’s education, you’ll have to choose between them. You may decide based on which is more beneficial to the most people, or which causes the least amount of harm. Using the example of choosing between saving for retirement or your child’s education, consider that your child may be able to get a scholarship or take out a loan, but if you don’t have retirement savings, you will have little to no income to live off of in your retirement years. In this case, prioritize your retirement, as it would cause more harm to put your child’s education first.

### Step 4 Taking action

Once you’ve established, specified and prioritized your goals, you can start making progress toward them. To keep your spending in check while on the way to your financial goals, before making a large purchase ask yourself, “Will this get me closer to my goal?” Keeping your goals top of mind can help you stay positive, as you will be able to track how putting money toward buying a home rather than a new designer handbag gets you closer to your goal, rather than focusing only on the fact that you don’t have the handbag. Keep in mind that your goals will need to be flexible—just

as your priorities and needs will change as you grow older, your goals will also need to change. You should reevaluate your goals at least every few years to make sure they still apply and you are making progress toward them. And remember, the sooner you set your goals, the more time you have to save and the higher the likelihood you’ll reach them.

## Brother Ruben Studdard

**R**uben Studdard was born in Frankfurt, West Germany, while his father was stationed there with the U.S. Army, and grew up in Birmingham, Alabama. The youngest son of two teachers, at the age of three, he sang for the first time at the Rising Star Baptist Church in his hometown of Birmingham. He continued singing gospel in church, performing solos as a child while his mother sang in the local choir. While at Huffman High School, he played football and received a scholarship to Alabama A&M University. While at Alabama A&M, he joined Phi Mu Alpha Sinfonia.

After growing up listening to his mother's Donny Hathaway albums, Fred Hammond, and gospel music, Studdard began to pursue a career in the music industry, majoring in voice studies at Alabama A&M. He sang with Just a Few Cats, a popular local Birmingham jazz and R&B band founded by members of Ray Reach's UAB Jazz Ensemble, along with other local musicians. Years later, Studdard stated: "A lot of people don't realize how hard I was trying to get into the business before American Idol. I was making demos and just working so hard." A back-up singer from Just a Few Cats asked him to accompany her to Nashville, Tennessee for an audition on the 2003 second season of American Idol.

When auditioning, Studdard sang Stevie Wonder's "Ribbon in the Sky." This guided him to being one of the local finalists. On American Idol, he impressed viewers with his performances of the Leon Russell/Bonnie Bramlett song "Superstar" and the Peabo Bryson/Regina Belle duet "A Whole New World." During his time on the show, Studdard received praise from music legends such as Lionel Richie, Neil Sedaka, Robin Gibb of the Bee Gees, Luther Vandross, and Gladys Knight.

During the televised competition, Studdard gained the nickname "Velvet Teddy Bear" and was noted for his shirts printed with "205," the telephone area code of his hometown of Birmingham.

He won the contest over runner-up Clay Aiken, becoming the second American Idol winner. Governor Bob Riley declared March 11, 2003 as "Ruben Studdard Day."

Ruben released his debut single, a cover song, *Flying without Wings* by West Life, where he won the American Idol. He sang it during the show's finale. In 2003, it was released by his producers, Baby Face and the Underdogs. In 2004, he released a debut album titled *Soulful* that contained the single, *Sorry*. He released his second album in 2004, which was a debut gospel album. He made a cameo in *Scooby-Doo 2: Monsters Unleashed* in the same year. The release of the third album was after two years, titled *The Return*, followed by *Love* in 2008.

He released others like *Unconditional Love* and *Letter from Birmingham*. He has been featured in films such as *Lifted* and *The Perfect Gift* and some non-album singles like *Flying Without Wings* and *Celebrate Me*. He has made his appearance in several TV shows such as *Life on a Stick*, *Eve*, *Eight Simple Rules*, and *All of Us*. He also made guest appearances in *One on One*.

During his career, he has collaborated with megastars such as Stevie Wonder and Eric Benet, earning him a platinum-selling debut album. Most of his singles have made top of the US Billboard music charts. In 2008 he published a cover album named *Ruben Sings Luther* due to his comparison with famous R&B singer Luther Vandross.

He received a Grammy Award for Best Male R&B Vocal Performance in 2003 for song *Superstar*. Studdard has been nominated for several awards, including Teen Choice Award, three Billboard Music Awards, and one Image Award.

Ruben is a member of Geometry Lodge No. 410, as well as, all York Rite Houses. He is a Class of 2015 inductee into the Most Worshipful Prince Hall Grand Lodge of Alabama's Hall of Fame.

## Keeping our MWPHGL of Alabama Veterans Informed

### U.S. Department of Veterans Affairs (VA) Programs for Minority Veterans

The Minority Veterans Program (MVP) conducts outreach activities, disseminates information, and serves as a resource center for the exchange of information regarding the improvement of services available to minority Veterans. The program coordinators hear and evaluate complaints and queries made by or on behalf of minority Veterans and assist minority Veterans on an individual basis. The term “Veterans who are minorities” means Veterans who are identified as African Americans, Asian American/Pacific Islander, Hispanic, Native American/Alaska Native, and Native Hawaiian. The main goal for Minority Veterans Program Coordinators (MVPC) is to increase the awareness of issues on minority Veterans. This includes developing long-term strategies to encourage eligible minority Veterans to participate in VA benefit programs. Additionally, MVPCs advocate on behalf of minority Veterans and recommend ways to improve the delivery of services within VA facilities.

Each VA Regional Office has a Minority Veterans Outreach Coordinator who is a direct point of contact for you to learn more about what benefits you qualify for, assist you with applying for those benefits, and refer you to other organizations and resources that will help you meet your needs.

### Native American Direct Loan (NADL) Program

This program helps eligible Native American Veterans finance the purchase, construction, or improvement of homes on Federal Trust Land or reduce the interest rate on such a VA loan. Native American Veterans may use these direct loans to simultaneously purchase and improve a home or refinance another VA direct loan made under NADL to lower the interest rate.
