Re: Clandestine Activity Within the Jurisdiction (Derrick P. Whitlow, Umar A. Hicks, Curtis Turner, Reginald Mattingly, and others)

Greetings:

This is to inform you of a lodge operating here in the Jurisdiction of Alabama, under a charter of another Jurisdiction. The lodge to which I am referring is a clandestine operation and is hereby deemed a clandestine lodge.

In a letter dated January 21, 2021, I communicated with the Grand Master of the Jurisdiction under which this clandestine lodge is operating, concerning the lodge's existence. He assured me that he would rectify the problem. Yet, the clandestine lodge still exists.

This clandestine operation is composed of known expelled members of this jurisdiction and others; namely:

And others who are presently unknown, whose names will be published when discovered.

Suspended/Expelled Masons cannot jump on the rolls of another jurisdiction. That is irregular masonic activity. Masonry has rules and etiquette, and we are to abide by those rules and etiquette.

Any masonic intercourse, whatsoever, with the above-named expelled members and/or the clandestine lodge where they claim membership, is prohibited, and will result in immediate expulsion. Take due notice and govern yourselves accordingly!
