

In an attempt to give suspended Brothers an opportunity to become active again during these tough economic times, our Most Worshipful Grand Master has devised a plan named • TARP- Traveling Again Reclamation Program. This program is designed to allow suspended members to reinstate for a more affordable fee.

Members suspended before June, 2002, can reinstate by paying the following:

- \$20.00 reinstatement fee
- \$10.00 taxes
- \$25.00 registration
- \$50.00 assessment (Have two years to pay the remaining \$150.00)
- \$105.00 Total

Members suspended after June, 2002, can reinstate by paying the following:

- \$20.00 reinstatement fee
- \$10.00 taxes
- \$25.00 registration
- \$50.00 assessment (Have two years to pay the remaining \$200.00)
- \$105.00 Total

TARP serves a two-fold purpose: (1.) It gives suspended Brothers a more affordable means of reinstating and (2.) It gives dying lodges a final opportunity to salvage their existence by increasing their numbers before being forced to close or merge. Our Grand Master has extended a challenge for the members of this jurisdiction to go out and reclaim our lost Brothers. TARP will be in effect through July 31, 2018.

Grand Master Hawkins Visits Prince Hall Monument

n January 19-22, 2018, Grand Master Hawkins attended the annual meeting of the Southeast Region Conference of Grand Masters, held in Barbados. While in Barbados, Grand Master Hawkins was fortunate enough to view the monument erected in honor of our founder, Prince Hall. The monument was erected on the grounds of the Most Worshipful Prince Hall Grand Lodge of the Caribbean's Grand East. Chiseled on the monument are the names of some of the Prince Hall Grand Masters at the time of its unveiling in 1999, to include that of our very own Dr. William O. Jones. The Southeast Region is composed of the Jurisdictions of Alabama, the Bahamas, the Caribbean, Florida, Georgia, Mississippi and Tennessee.





Region Four Lays Wreaths for Past Grand Masters

he Honorable Corey D. Hawkins, Sr., Esq., and members of Region 4, which is comprised of Districts 7, 8 and 10, recently held wreath laying ceremonies for Past Grand Master Malachi Morse, Sr. and Past Grand Master Dr. William O. Jones in Tuskegee, Alabama. Past Grand Master Morse became a Master Mason in 1919, a Royal Arch Mason and Knights Templar in 1920, was advanced as a Sublime Prince of the Royal Secret in 1945, when he also became a Noble of the Mystic Shrine. In 1952, he was appointed Deputy for the Orient of Alabama and in 1955 he became a Sovereign Grand Inspector General – Active. He later served as Depu-



ty of the Desert in 1962. He was a Past Master of Silver Trowel Lodge No. 10 and served as Grand District Deputy of District No. 7. From 1963 to 1967, he served as Deputy Grand Master. In 1967, he served as Most Worshipful Grand Master, presiding over the unexpired term of Past Grand Master Charles V. Hendley, Esq.

In his professional life, PGM Morse served as a professor at Tuskegee Institute, in their painting laboratory. It was on April 23, 1984, that PGM Morse would enter that Celestial Lodge, the house not made with hands, eternal in the heavens.

Past Grand Master Dr. William Oliver Jones was born in Westminister, South Carolina on December 2, 1936, to Lawrence Aaron and Alpha Oglesby Jones. He was the youngest of the couple's four children. Dr. Jones was valedictorian of his high school class and continued his education at South Carolina State College where he graduated Summa Cum Laude in 1959. It was at South Carolina State College where Dr. Jones met and married his companion of 56 years, Dr. Mary Ann Jones.

Dr. Jones' Masonic resumé consists of some of the following: Past Master of Lewis Adams Lodge Number 67, Past Grand Senior Warden, Honorary Past Most Eminent Grand Master of the Grand Encampment of Knights Templar PHA, Sovereign Grand Inspector General – Active of the United Supreme Council, Southern Jurisdiction where he served honorably as its Grand Auditor and also its Lieutenant Grand Commander, President of the Conference of Grand Masters and Most Worshipful Grand Master of the Jurisdiction of Alabama from 1999 to 2013.

Dr. Jones graduated Summa Cum Laude with a Doctor of Veterinary Medicine from Tuskegee Institute and with a Ph.D. with the highest distinction from Cornell University. He earned the rank of Colonel in the United States Army from which he retired in 1996.

Past Grand Master Jones was an accomplished and distinguished professor in the College of Veterinary Medicine at Tuskegee University for 38 years. He was the first African American Veterinarian to earn board certification as a Veterinary Clinical Pathologist from the American College of Veterinary Pathologists, the first recipient of the Norden Distinguished Teacher Award in Veterinary Medicine and a two-time recipient of the School of Veterinary Medicine Outstanding Teacher of the Year Award.

It was on January 16, 2015, when PGM Jones departed this life destined for that house not made with hands, eternal to the heavens. *Contributor – RW George D. Echols*

From Whence We've Come... Bro. James Adams

B ro. James Adams was born in Marengo County. He lived a very fruitful and productive life in Sweet Water, Alabama. He was born February 8, 1880 to Henry and Bettie Sullivan Adams.

Bro. Adams was married to Delcia Adams and they had 13 children. After her death, he married Ada Rogers and they adopted two children. Upon her death, he married Mary P. Adams.

Brother Adams received very little education. The only education he received was for three months, which was provided by Collis Norris.

Bro. Adams was a strong leader in his community. Many knew him or called him "Uncle Jeans." The first church he joined was Morning Star Baptist Church located in Aim Well, Alabama. He gave freely of his time and service to ensure that successful programs were carried out. His



notable contribution was to the Independent Missionary Baptist Church. He believed strongly in the bible and he served as a Sunday school teacher and superintendent. Due to his regular attendance and trust worthiness, he was given the position of treasurer of the church. He also served as a deacon in the Independent Baptist Church until his death. Bro. Adams spent over 98 years of his life to the Master's services for God's blessings. He took great pleasure in singing his favorite song "Hold to God's Unchanging Hand."

Bro. Adams provided for his family by farming. He owned and farmed his own land. The usual crops he raised provided food for his family. Much of the food he raised was sold along with a variety of cash crops such as corn, cotton and potatoes. For a few years, he worked away from home as a logger for the Coxhead Mill in Sweet Water. During the fall season of the year, he made cane syrup. He sold syrup and made some for other families who brought their cane to his mill.

Bro. Adams served the community as a licensed midwife for 60 years or more. This was most unusual for a man. It was most commonly done by a woman. This job required assisting mothers with child birthing. During his life-time, he delivered a countless number of babies in the area.


Bro. Adams most notable contribution was to the purchasing of land and assisting in building Sweet Water Lodge No. 755 in Sweet Water, Alabama. Members who assisted him in setting up the lodge were Bros. James S. Adams, Frank Lofton, Moulin Dixon, Dennis Parten, Lawrence Hudson, Ludie Dixon, Frank Parten, Len Rodgers, Leroy Washington, Willie Webb, Nero Westbrook, Columbus Williams, Harry Pearson, Thomas Johnson and Governor J. Tensely, Sr. He served over fifty years in the masonic lodge. Bro. Adams served as the First Worshipful Master of Sweet Water Lodge No. 755 and as the Worthy Patron of Bright Star Chapter No. 616A. Sis. Cora Flint served as Worthy Matron at that time. It is to this giant of a man who had the desire, dream, and ambition to erect the building for Sweet Water Lodge No. 755 that still serves dedicated men who are interested and want to be associated with the masonic lodge in Sweet Water today.

A Case for Charity, use life insurance to benefit a favorite charity. It can benefit you too!

ave you entertained the idea of leaving a sizeable gift to charity after you pass away? Consider using your life insurance policy to support your favorite cause. Here's how:

1. Name the charity as the beneficiary of your life insurance policy so the death benefit automatically gets paid to them.

Pros: The policy proceeds, while includible in your estate at your death, will qualify for the estate tax charitable deduction to the extent the policy proceeds are paid to a charity.

Cons: While a beneficiary designation is simple, private and requires little documentation, it is important to understand that because you retain control of the policy you will not be able to take any income tax deductions during your life.

2. Donate your life insurance policy to charity.

Pros: This approach allows you to make your donation by transferring all rights of ownership in the policy to the charity. Where future premiums are required, your payments can be structured to qualify as charitable deductions for income tax purposes. The charity benefits since it has control of cash values and dividend rights, and receives the death benefit free of federal income, gift and estate taxes. Probate and other administrative costs and delays are also avoided.

Cons: As the donor, you lose control of the policy.

3. Help the charity purchase a new policy. Under this approach, the charity names itself as owner and beneficiary and is responsible for making premium payments. Of course, you can assist them in the process by making cash contributions equal to or greater than the needed premium dollars on an annual basis.

Pros: If structured properly, an annual charitable deduction should be available, subject to the general limitations placed on charitable contributions.

Cons: The charity is not obligated to maintain the policy nor are you obligated to continue premium contributions. If this plan is intended to serve as a future endowment, both parties must understand their roles if the plan is to be successfully brought to completion.

4. Gift assets to the charity and replace family wealth through a wealth replacement trust.

Pros: By directing the tax savings generated by your charitable gift to the purchase of a life insurance policy, you can donate your assets to charity and still provide a benefit to your heirs.

Cons: You'll need to make sure the life insurance is owned by your heirs or by an irrevocable life insurance trust (ILIT) to ensure that the policy proceeds will not be included in your estate at your death and that your heirs will receive the entire death benefit without losing some of it to estate taxes.

Message from the Grand Medical Registrar

What's that ringing sound in my ear?

rectings brothers.

Let us give thanks to the Almighty Architect who keeps on blessing each and everyone of us on a daily basis. I'm going to discuss a subject that some people may describe as a ringing sensation or "weird sound in my ear." These sounds are typically classified as tinnitus. Tinnitus is defined as a noise that is often associated with a buzzing or ringing sound in the ear. These sounds may be in one or both ears. The length of the ringing or buzzing can be constant or it can come and go. It can be associated with hearing loss.

Some causes of tinnitus are being exposed to loud noises, certain medications, head injuries or even too much wax build-up in the ear. These are a few examples of causes of ringing in the ear. If you are experiencing any of these symptoms, you should follow up with your primary physician to possibly discern the underlying reason for the noise in your ear. The noises in the ear can be quite irritating but seldom indicates a serious underlying condition.

In today's society, it is quite common to see all ranges of individuals with some type of electronic device plugged into their ear. Unfortunately, we sometimes feel we cannot appreciate the sound coming from our devices unless we turn the volume to the highest level. You may have noticed that you can sometimes hear the sound coming from a person's electronic device next to you. This is excessively too loud for the ear. You may have been told as well, that your device is loud. Learn to respect your hearing and keep the volume of electronic devices at recommended levels to preserve your hearing and possibly avoid these sounds from occurring in your ear.

Another way we commonly lose hearing and have problems with tinnitus is the use of lawn equipment. I had a patient that began experiencing tinnitus that was progressively getting worse. After some investigation, it was determined that his tinnitus problems were due to the fact that he operated a lawn service but never protected his ears. He was instructed on the proper use of wearing ear protective devices. He gradually had improvement of the annoying ringing sounds in his ears. Pay attention to how often your neighbor, or even yourself, use ear protection when you are around loud noises. It would be advisable if you do not already use protection to start now.

As a result, Mount Olive Primary has developed strong relationships with Phoenix Lodge No. 428 and local businesses and churches in the area. Partners in Education support the school by being visible at school activities, being guest readers in classes, serving as judges for school contests, such as door decorations during Red Ribbon and Read Across America Weeks, and providing financial support, materials and supplies, and human resources.

Brothers Called Home by the Grand Architect

Syvalouis N. Nance, Sr. was born April 27, 1922 in Enterprise, Ala., the fifth of the late J. E. and Mamie Gilley Nance's 10 children that included seven sons and three daughters. He was the epitome of a life well-lived. In the 95 years Syvalouis spent on this earth, Syvalouis impacted and influenced countless others through his kindness, warmth and generosity. The eldest of J. E. and Mamie Gilley Nance's descendants at the time of his death, Syvalouis was held in high esteem as the patriarch of the Nance family. He was a source of sage advice and informative, entertaining family tales. Family members marveled at his work.

Syvalouis, known as "Vick" to his family and friends, received his early education at Coffee County (Ala.) Training School and joined Johns Chapel AME Church at an early age. He enrolled at Tuskegee Institute in September of 1942 and left school after three months, after being drafted into the United States Army.

He was honorably discharged with the rank of sergeant and re-enrolled at Tuskegee in 1946, where he met his future wife,

Gladys Coprich, a graduate student from Winfield, Ala. They were married in 1950. Syvalouis graduated with a bachelor's degree in vocational agriculture in 1949 and later earned a master's degree in that discipline.

Syvalouis was a man of God, faithfully attending Galilee Missionary Baptist Church for more than 67 years, and was a longtime Deacon. He also served as church secretary. His mild-mannered temperament and unflagging work ethic made him an effective leader in the numerous organizations he was affiliated with. He served as President of the Colbert County Teachers Association; President and Treasurer of the Shoals Tuskegee Alumni Club; Worshipful Master of Hopewell Lodge No. 198, Leighton, Ala.; Treasurer of the Colbert County, Alabama Democratic Conference; and a member of Colbert County Retired Teachers Association.

He received numerous awards, honors and certificates for his service to his community and the organizations he was affiliated with. They include: the 2014 Lesley Temple CME Church Unsung Hero Award, Shoals Tuskegee Alumni Club Certificate of Appreciation, 2015 induction into the Prince Hall Grand Lodge Free & Accepted Masons of Alabama Hall of Fame, Worshipful Master of the Shoals Service and Dedication Award, Alpha Kappa Alpha Sorority Service Award, the Alabama Vocational Agriculture Teachers Association Service Award, and the 2017 Colbert County Alabama Democratic Conference Julia Doss Trailblazer Award, just to name a few.
